

## THE DRAKE VIEW FROM OUR INVESTMENT BANKERS

Whilst 2023 saw a volatile and uncertain market, financial investors and corporate buyers continued to advance their strategic agendas for digital innovation and cost optimisation. This drove robust deal-making activity in the Digital Services vertical especially for tech-enabled and security businesses, as buyers search for disruptive, inherently secure and proprietary IP. Overall, the quarter saw landmark dealmaking, with 315+ & \$3.7bn+ disclosed M&A deals and 340+ & \$4.3bn+ disclosed fundraises in Q4 2023¹, including:

- Insight Enterprises acquired SADA Systems for \$800m
- NTT Data Business Systems acquired Sapphire Systems for an undisclosed amount
- Thales acquired Tesserent for \$113m
- Viatel Technology Group raised an undisclosed amount of development capital from Macquarie Group
- Skytap raised \$18m of venture funding from Vistara Growth
- DSP raised \$93m of development capital from LDC

Looking ahead in Q1 2024, we expect further market consolidation and private equity's continuous investment in bolt-on acquisitions and its abundance of dry powder to drive more investments in the space. Digital Services will continue to spearhead M&A activity, especially workflow and operation efficiencies, Al solutions and the modernisation of legacy tech remain important investment themes in 2024.
